

**PETITION FOR ADDITION TO OR ALTERATION OF THE _____ DOMESTIC WASTEWATER
IMPROVEMENT DISTRICT**

**TO THE HONORABLE BOARD OF DIRECTORS OF THE _____ WASTEWATER
IMPROVEMENT DISTRICT OF YAVAPAI COUNTY, ARIZONA:**

The undersigned real property owner(s) requests addition to _____ elimination from _____ the _____ Domestic Wastewater Improvement District pursuant to Sections 48-901 to 48-966, inclusive, and Sections 48-1011 to 48-1019, inclusive, Arizona Revised Statutes (the "County Domestic Wastewater Improvement District Laws"), and all amendments and supplements thereto.

If a petition for addition to the district, the necessity for the proposed addition is the need for domestic wastewater service provided by the _____ Domestic Wastewater Improvement District and maintenance and other local improvements as may be undertaken by the District and the financing of such improvements by the issuance of bonds secured by special assessments on the parcels of land so benefited in said district, charging and collecting fees and charges as may be permitted by law, and levying taxes within such district to operate and maintain said improvements. The public convenience, necessity and welfare will be promoted by the proposed annexation and the real property to be included therein will be benefited by the improvements which can be ordered by the district.

If a petition for elimination from the district, the necessity for the proposed elimination is that the property owner(s) do not benefit from inclusion in the district. The public convenience, necessity and welfare will be promoted by the proposed elimination from the district and the real property to be eliminated therein will be benefited.

The boundaries of the proposed change are as shown on the attached description, marked Exhibit A and the attached plat, marked Exhibit B.

The petitioners pray that the Board of Directors set this petition for hearing; direct notice be given to all interested property owners concerning the hearing in the manner prescribed in A.R.S. § 48-905(B); after consideration of any objections that may be made, enter a formal order declaring its findings; and declare the boundary change approved.

If a petition for addition to the district, this petition shall be deemed an acknowledgement by the petitioners of the district's authority to incur the expenses related to the district's maintenance or improvements, and to take all action to initiate and complete such improvements. The petitioners understand and acknowledge that in the event any property assessed within the district is, or becomes, subject to the ownership or control of the United States Government or any agency or instrumentality of, or which is controlled by, the United States Government, the portion of the costs assessed against such property may be required to be reapportioned to the remaining property within the district if and to the extent that the assessment cannot be enforced against the property owned or controlled by the United States Government or any agency or instrumentality of, or which is controlled by, the United States Government.

Petitioners agree to pay all expenses connected with the proceedings in accordance with A.R.S. §48-1014(C).
