The ADHS County-Level School Benchmark Dashboard Updated Today


This dashboard is used to determine the level of community spread of COVID-19 in Yavapai County for the two weeks ending March 21st. Cases per 100,000 individuals increased to 44/100k vs. 35/100k for the week ending March 14, however the positivity rated decrease from 3.5% 50 3.3%. Overall, the dashboard indicates the county is at moderate transmission.

Yavapai County will be receiving more Johnson & Johnson vaccine next week.

Safeway/Albertson's give the option for Johnson & Johnson. Verde Valley Medical Center and Spectrum Healthcare community clinics are offering the Johnson & Johnson vaccine in rural areas. The Yavapai County phone bank is available to assist residents without computers or internet – call 928-442-5103.

Yavapai County reports 26 new COVID-19 Cases. Since March 2020, the county has tested **108,230** residents for COVID-19 with **18,328** positive cases and **488** deaths. Cross-referencing of cases for duplicates result in a +3 net cases. Yavapai Regional Medical Center is caring for **5** COVID-19 patients, VVMC has **no** COVID-19 patients, and the VA has **1** COVID patient.
