## First Dose Appointments for the Moderna Vaccine End this Week

Spectrum Healthcare's points of dispensing (PODs) will be offering first dose appointments through April 17<sup>th</sup>, and Yavapai Regional Medical Center's POD at the old Sears Building at Gateway Mall will end first dose appointments on Wednesday, April 14<sup>th</sup>. Spectrum's PODs will be open Saturday/Sunday/Monday 8-4, the Cottonwood POD will be open Wednesday/Thurs/Friday 8-4. YRMC's POD is open 9:30 a.m. – 6:30 p.m. Monday/Tuesday and Wednesday. Anyone with a 2<sup>nd</sup> dose appointment can walk-in on the dates the PODs are open. Yavapai County will receive only 400 doses of Johnson and Johnson vaccine this week, and it is expected supply will be unstable for the next few weeks. Community Clinics with the Johnson & Johnson vaccine this week are taking place in Sedona at the HUB on Tuesday from 10:00 a.m. – 2:00 p.m. and in Ash Fork on Wednesday 9:00 a.m. – 12:00 Noon at the Ash Fork Library. Many pharmacies are also carrying the Johnson & Johnson vaccine. The VA is offering walk-in appointments for veterans, their spouses, or caregivers with the Moderna vaccine.

The Yavapai County Emergency Phone Bank is open to assist anyone without internet or computer. Call 928-442-5103. The next YCCHS update will be on Thursday, however the dashboard on the website will be updated Mondays-Fridays.

Yavapai County reports 28 COVID-19 Cases over the Weekend. The county has tested 110,170 residents for COVID-19 with 18,446 positive cases and 491 deaths. Cross-referencing of cases for duplicates result in a net +23 cases. Close to 132,000 doses of COVID-19 vaccine have been administered in Yavapai County, with 81,646 residents or 35% of the population receiving at least one dose, and over 55,000 people fully vaccinated. Yavapai Regional Medical Center reports 4 COVID-19 patients, VVMC reports 3, and the VA has no COVID-19 patients.
