April 15th Morning Update - Yavapai County Community Health Services **Yavapai County has 71 COVID-19 Cases**

45,310 Arizonans have been tested for COVID-19, and **3,962** cases, with **142** deaths. **1,754** Yavapai County residents have been tested with **1,683** results negative, **3 recovered**, and **1** death. While there were three cases reported overnight, two cases from earlier were determined to be duplicates resulting in a net gain of one. VVMC reports **5** hospitalizations from COVID-19, with **8** persons under investigation (PUI). YRMC reports **4** hospitalizations with COVID-19, with **4** PUIs on West Campus, **2** on the East Campus. The VA reports no COVID-19 hospitalizations or PUIs. A PUI is an in-patient admitted for care who has been tested with results pending.

Governor's Press Conference offered many Announcements

- Walgreens will open two drive-through testing sites in AZ, the locations of the drive-throughs will be posted on azhealth.gov.
- The State has received 15 of the Abbott Labs testing machines, which can rapidly conduct COVID-19 tests, which will be distributed to test vulnerable populations.
- The University of AZ will partner with the state to create 250,000 antibody tests to aid in identifying if health care workers and first responders have had COVID-19. It could then roll out to other front-line workers such as those in grocery stores and restaurants. The scale of the UA antibody testing could be the largest in the country.
- Three executive orders related to health care: certification changes for caregivers, additional data-reporting requirements, enhanced surveillance – sharing COVID info with first responder agencies, and telemedicine coverage for workers' compensation.
- Dr. Christ, Director of ADHS, added that the state is also in conversations with CVS for testing.
