Spectrum Healthcare's Last Day for First Dose Appointments at their PV POD is Saturday

Spectrum Healthcare's points of dispensing (PODs) will be ending first dose appointments April 17th and there are plenty of appointments today and tomorrow at the AZ Dermatology Suite, 3001 N. Main Street. The PV POD operates Saturday, Sunday and Monday 8-4, the Cottonwood POD, Wednesday, Thursday, Friday 8-4 at the Verde Valley Christian Church. Spectrum Healthcare will continue administering COVID-19 vaccine at their facilities in Prescott, Cottonwood, and Camp Verde when the Vaccination Stations close. Additionally, Spectrum Anywhere Healthcare Teams will continue to mobilize into rural communities, local facilities, and individual homes.

YRMC's POD at the old Sears Building has ended first dose appointments, however 2nd dose appointments will proceed as scheduled. For questions relating to second dose appointments, call 928-708-4556. The YRMC schedule is as follows: *April 15th-May 1st (closed Sunday): 2nd dose ONLY by appointment (no 1st dose walk-ins or appointments) 8:00AM - 5:00PM*.

Yavapai County reports 16 COVID-19 Cases and 1 Death. The county has tested **110,893** residents for COVID-19 with **18,503** positive cases and **494** deaths. Yavapai Regional Medical Center reports **8** COVID-19 patients, VVMC reports **7**, and the VA has **no** COVID-19 patients.
