## **April 16<sup>th</sup> Afternoon Update - Yavapai County Community Health Services** **Yavapai County Reports 5 Recovered Individuals**

**47,398** Arizonans have been tested for COVID-19 and **4,234** positive cases, with **150** deaths. **1,800** Yavapai County residents have been tested with **1,731** results being negative, **69** positive, **5 recovered**, and **1** death. While there were no new cases reported overnight, two cases from earlier were determined to be duplicates. VVMC reports **5** hospitalizations from COVID-19, with **14** persons under investigation (PUI). YRMC reports **4** hospitalizations with COVID-19, with **10** PUIs on West Campus, **4** on the East Campus. The VA reports **1** COVID-19 hospitalization and no PUIs. A PUI is an in-patient admitted for care who has been tested with results pending.
