## April 17<sup>th</sup> Morning Update - Yavapai County Community Health Services Yavapai County Has 71 COVID-19 Cases

47,398 Arizonans have been tested for COVID-19 and 4,507 positive cases, with 169 deaths. 1,875 Yavapai County residents have been tested with 1,804 negative, 5 recoveries, and 1 death. VVMC reports 5 hospitalizations from COVID-19, with 14 persons under investigation (PUI). YRMC reports 3 hospitalizations with COVID-19, with 11 PUIs on West Campus, 4 on the East Campus. The VA reports 1 COVID-19 hospitalization and no PUIs.
