## What to Expect after Getting a COVID-19 Vaccine

COVID-19 vaccinations will help protect you from getting COVID-19. You may have some side effects, which are normal signs that your body is building protection. These side effects may affect your ability to do daily activities, but they should go away in a few days.

### Common side effects

**The arm where you got the shot:** Pain, Swelling

**Throughout the rest of your body:** Fever, Chills, Tiredness, Headache

**When to call the doctor** - In most cases, discomfort from fever or pain is normal.

- If the redness or tenderness where you got the shot increases after 24 hours
- If your side effects are worrying you or do not seem to be going away after a few days.



**Some people experience more severe side effects after the second dose** - The Moderna and Pfizer vaccines are administered in two doses, spaced apart by about 28 and 21 days, respectively. More users of V-safe, the CDC's tool to report vaccine side effects, reported side effects within a week of getting their second shot compared to the first, according to a Jan. 27 CDC update.

**Vaccine POD Update** – According to the ADHS Vaccine Administration Dashboard, Yavapai County has administered close to 42,000 COVID-19 vaccines with 37,650 first doses, and 4,375 second doses.

Appointments for the PODs at Findlay Toyota Events Center, the old Sears at Gateway Mall, and Verde Valley Christian Church are filled for this weekend. Appointments are mandatory, with no walk-ins, however with cancellations it is possible appointments become available,

### Yavapai County reports 45 COVID-19 Cases and 2 Deaths

The county has tested **98,013** residents with **16,956** positive cases, **7,133** recovered, and **423** deaths. YRMC is caring for **30** COVID-19 patients, Verde Valley Medical Center reports **9** COVID patients and the VA reports **2**.
