## January 20 Update: Yavapai County reports 83 COVID-19 Cases and 6 Additional Deaths

Over **3.6 million** Arizonans have been tested for COVID-19 with **4,845** positive results today and **9** additional deaths reported statewide. Yavapai County has tested **91,031** residents with **15,401** positive cases, **6,077** recovered, and **331** deaths. YRMC West has **67** COVID-19 patients, YRMC East is caring for **18** patients. VVMC reports **23** COVID-19 hospitalizations. The VA reports **10** COVID-19 patients.

## **Update on PODs:**

All appointments are filled at the YRMC Point of Dispensing (POD) in the old Sears building at Gateway Mall for this Thursday and Friday. YRMC is also providing second doses to the Phase 1a group this week but is expected to re-open the POD as vaccine supply is replenished.

Spectrum Healthcare's POD at Findlay Toyota in Prescott Valley and in Cottonwood are filling up quickly for next week. They plan to be open through the weekend and throughout the month, so be patient in registering for an appointment.

Phase 1b includes: Education & Childcare Workers, Protective Services Occupations, Essential Services/Critical Industry Workers, Adults with High-Risk Conditions in Congregate Settings, Adults 65 and Older.

YCCHS buildings are not open for walk-in assistance due to COVID mitigation measures. Residents needing our help must call either our main line 771-3122 or the Emergency Phone Bank at 442-5103. There are many volunteers manning the phone bank who can assist you.

Next week is the official start of the **CDC COVID-19 Retail Pharmacy Program** beginning with only 100 Fry's, Safeway and Albertson's throughout the state with the intent to have over 800 pharmacies once vaccine is more available. Other opportunities for receiving vaccine will be coming online, and as we receive the information it will be posted on the Yavapai County Vaccine Information page.

On the horizon, **Johnson & Johnson** trials show single-shot COVID-19 vaccine effective; they hoping for emergency use authorization later this month.
