**BinaxNOW Tests**: The shelf-life of the BinaxNOW Ag Card, BinaxNOW COVID-19 Ag Card Home Test, BinaxNOW COVID-19 Antigen Self-Test, BinaxNOW COVID-19 Ag Card 2 Home Test, and the BinaxNOW COVID-19 Ag 2 Card **going forward are now 15 months at room temperature**.

- We expect Abbott will also have a letter and list in the coming weeks for kits that recently expired and will qualify for an extension of 15 months.
- Please consider holding on to recently expired kits as they may be extended.
- We will keep you updated on the situation.

Yavapai County reports 1,229 COVID-19 Cases and 15 Deaths since Friday, January 14, 2022. The county has tested 40,713 residents for COVID-19 in the past 6 months, and there have been 125,676 positive cases and 1,026 deaths since the beginning of the pandemic. Yavapai Regional Medical Center reports 56 COVID-patients, VVMC reports 20 patients, and the VA reports 6 patients. The County is still experiencing high transmission of COVID-19 with a 24.6% positivity rate and 664 cases per 100,000 residents for the week ending January 2, 2022. If you are experiencing symptoms of COVID-19 or what seems to be a bad cold, please get tested for COVID-19 and/or Flu.
