YCCHS Update: July 13, 2022

As the summer progresses, we've seen an increase in large gatherings and local events, as well as a significant increase in Covid-19 cases in Yavapai County. Most hospitalizations and deaths from COVID-19 in Yavapai County still occur in unvaccinated individuals. Currently, 23% of infections occurred in fully vaccinated individuals with 6.3% of those being individuals who received the booster. 17.4% of those hospitalized for COVID-19 were fully vaccinated. With this in mind, it's important to still follow published CDC guidelines to reduce transmission. CDC guidelines can be found at [How to Protect Yourself & Others | CDC](#).

The U.S. Department of Health and Human Services is providing free COVID-19 tests through covid.gov/tests. Every home in the U.S. is eligible to order a third round of free at-home tests. Yavapai County reports 575 COVID-19 Cases and 6 Deaths since Wednesday, July 6th, 2022. There have been 51,928 positive cases and 1,251 deaths since the beginning of the pandemic. Yavapai Regional Medical Center reports 23 COVID patients, VVMC reports 5 patients, and the VA reports 5 patients. If you are experiencing symptoms of COVID-19 or what seems to be a bad cold, please get tested for COVID-19.
