589,754 Arizonans have been tested for COVID-19 with **58,179** positive cases, **1,384** deaths. Yavapai County has tested **16,799** residents, with **513** positive cases, **260** recovered, and **7** deaths. YCCHS is contact tracing all new cases and interviewing past positives to assess their recovery status. Yavapai Regional Medical Center reports **12** COVID-19 patients and **1** person under investigation (PUI). Verde Valley Medical Center reports **9** COVID hospitalizations and **1** PUI. The VA has reported **1** COVID-19 hospitalization and no PUI.

Dr. Anthony Fauci, the nation's top infectious disease expert, warns the coronavirus pandemic is far from over as he and other U.S. health officials testified to Congress about the pandemic response.

He stated the next couple of weeks will be critical in our ability to address those surges we are seeing in Florida, Texas, Arizona and other states. He also said that the country needed to "establish a system" to respond to future outbreaks.

Dr. Fauci attributed the rapid spread to the contagiousness of the virus, and to extensive world travel by infected people. Covid's broad range of severity, from no symptoms at all to critical illness and death, with lung damage, intense immune responses and clotting disorders that have caused strokes even in young people, as well as a separate inflammatory syndrome causing severe illness in some children.

Fauci told the panel that the National Institutes of Health was "mounting a major effort" in collaborating with public and private partners to conduct vaccine trials "that harmonize with each other." He said multiple vaccines are being developed, and that one vaccine would enter phase three of testing in July.

"Although you can never guarantee, at all, the safety and efficacy of a vaccine until you actually test it in the field, we feel cautiously optimistic," Fauci said. He expressed confidence that a vaccine could be ready by the end of this year or early 2021, saying "it's when and not if."
