Another Vaccine on the Horizon

The Maryland-based Novavax reported on March 11 that overall, its vaccine was 96% effective in protecting people from mild, moderate, or severe COVID-19 disease if they were infected with the original coronavirus, and 86% with the UK variant, in their trials in the United Kingdom.

Novavax's vaccine can be stored at refrigerated temperatures, which could make it attractive for more vaccination sites that don't have the freezer capabilities that the Pfizer and Moderna vaccines require. The company expects to use the data from their United Kingdom trials to submit for regulatory authorization in various countries. It is not clear when it will seek U.S. authorization or if regulators will require it to complete an ongoing trial in the United States. The company has received \$1.6 billion from the U.S. government in funding for the vaccine trial and to secure 100 million doses.

Yavapai County reports 20 new COVID-19 Cases. The county has tested 104,478 residents for COVID-19 with 17,913 positive cases, 7,606 recovered, and 476 deaths. Through cross-referencing of cases for duplicates and classification of the late-reported cases by a local medical facility, there is a net +242 cases today.

Yavapai Regional Medical Center is caring for **12** COVID-19 patients, 8 on the West campus, and 4 on the East campus. Verde Valley Medical Center reports 1 COVID-19 patient, and the VA has no COVID patients.

The Spectrum POD in Prescott Valley is closed today. The Emergency Phone Bank is closed today reopening on Monday at 9:00 a.m. to assist people without computers and internet.
