May 5th Afternoon Update - Yavapai County Community Health Services Yavapai County has 139 COVID-19 Cases

Yavapai County has tested **2,920** residents, **139** positives, **11** recovered, and **2** deaths. These new cases are attributed to additional Mingus Mountain Academy cases, the County Jail, and the testing "blitz." The Epidemiologist continues to critically assess a large amount of test data, and we expect numbers to increase. YCCHS is closely monitoring the situation at Mingus Mountain Academy. More testing will take place on the campus tomorrow for students and staff and they have been supplied with a large quantity of personal protection equipment.

Spectrum Healthcare and YRMC participating in the Arizona Testing Blitz this Saturday, May 9

- **Spectrum** - 651 Mingus Avenue address in Cottonwood, and in Prescott at 990 Willow Creek Road from 8 a.m. – 4 p.m. The test is a nasal swab that is sent off to a clinical lab for official processing. This is not an antibody test. We can do those but need a doctor's order. Our service is free, but you may be charged to your insurance for the test. - **YRMC in Prescott Valley – with shortened hours: 8 a.m. – 12 Noon.** YRMC Del E. Webb Outpatient Center, 3262 N. Windsong Drive, Prescott Valley, Arizona. Free Testing will take place in the YRMC Del E. Webb Outpatient Center parking lot. Please use the main entrance from Windsong Drive. No physician order is necessary. Please bring identification in the form of a driver's license. People who present for testing should wear a mask if possible. No need to pre-register. Test results will take between 3 to 5 business days. There is no charge for this community service.
