November 23rd Update - Yavapai County Community Health Services Yavapai County reports 396 COVID-19 Cases, 4 Confirmed Deaths over the Weekend

2,482,346 Arizonans have been tested for COVID-19, with 302,324 positive results and 6,464 deaths reported statewide. Yavapai County has tested 60,598 residents with 4,641 positive cases (an average of 132 cases per day), 1,816 recovered, and 107 deaths. YRMC West has 22 COVID-19 patients and YRMC East is caring for 11, with 1 person under investigation (PUI). The Verde Valley Medical Center reports 21 COVID-19 hospitalizations and **no** PUI. The VA reports **5** COVID-19 patients.

Good news on the coronavirus vaccine front. AstraZeneca announced promising results from the late-stage trials of a COVID-19 vaccine. The vaccine does not need to be stored at subzero temperatures like Pfizer's vaccine, and it is a two-dose regimen. AstraZeneca executives said the vaccine is already being manufactured and the first 4 million doses could be ready in December, and 40 million could be delivered in the first quarter of 2021. The United States has pre-ordered 300 million doses of the vaccine.



The FDA has approved another COVID-19 Antibody Treatment. The drug, made by the biotech company Regeneron, is the second antibody

treatment to win emergency use approval from the FDA. Like Eli Lilly's treatment, this drug is only for the treatment of mild to moderate COVID-19 in people 12 years and older who are at high risk of developing more severe symptoms. It's not for patients who are hospitalized because of COVID-19 or who require oxygen therapy because of the virus. Regeneron said that initial doses will be made available to roughly 300,000 patients through a federal government allocation program. Those patients will not be charged for the drug but may have to pay part of the cost of giving the IV. Both Regeneron's drug and the treatment made by Eli Lilly are synthetic versions of human antibodies that mimic the immune system's ability to fight off harmful pathogens. They bind to the coronavirus and prevent it from invading cells. Both treatments are administered by intravenous infusion.

As with any emergency use authorization, the FDA provides fact sheets about the vaccines and treatments for healthcare providers, patients and caregivers. These fact sheets including dosing instructions, potential side effects and drug interactions.
