Introductions [Co-Chair Bob Roecker]

> Co-Chair Roecker called the meeting to order at 2:00 p.m. and welcomed those attending. Self introductions followed.

ITEM NO. 3 Informational reports [Co-Chairs and Committee]

- Doug Von Gausig reported that as of Tuesday, January 24th, Cottonwood and Clarkdale own their own water system. Diane Joens publicly thanked Bob Hardy with the City of Cottonwood for all the years of hard work he gave to help Cottonwood and Clarkdale obtain the water companies.
- > Diane Joens reminded everyone that the Verde Watershed Association in conjunction with several other groups is busy planning an all day conference to address Title II - Verde River Basin Partnership. The conference will be held at the Camp Verde Multi-Use Center on Saturday, February 11, 2006. This conference is open to the public with a \$10 registration fee without lunch and \$20 if you want to have lunch at the conference.
- > Diane Joens announced that Ed Wolfe was the newly elected President for the Verde Watershed Association. She also sincerely thanked Loyd Barnett for the time he dedicated as President of this organization. Loyd has every intention of staying active with the VWA.
- Diane Joens suggested sending letters to the Natural Resource Committee supporting the 2 water bills currently being heard: HB 2465, Water Resources, Regional Planning and HB 2462, Adequate Water Supply.

This group was going to work on a stakeholder list to form a Verde River Basin Partnership - this will be addressed at the February 11, 2006 Verde River Basin Partnership forum.
- No. 5 of the Coordinator's Report: Consensus reached by the WAC for the Coordinator to write a support letter for proposal by the University of Arizona to do geochemistry work in the Verde Basin at no cost to the WAC.

He stated that everyone should keep in mind that the TAC has not thoroughly reviewed the Report and that questions are welcomed, but answers may not be available today until further and closer review of the Report takes place.

He said that the Report is at the printer for completion and is hoping it is available February 11, 2006. He said that this is a big mile stone and that now the modeling effort can be started numerical model for a starting point to answer questions about our water resources. Mr. Melcher then introduced Kyle Blasch also with the USGS and one of the main leaders in this project. Other leaders during this project included Betsy Woodhouse and John Hoffman. Mr. Blasch thanked Coordinator Rasmussen and past coordinator John Munderloh for their continued support and then gave his presentation.
