# YAVAPAI COUNTY WATER ADVISORY COMMITTEE (YCWAC) MEETING MINUTES

The Water Advisory Committee (WAC) met on February 15, 2006 at 2:00 p.m. at the Verde Valley Manor, Godard Hall, 3400 E. Godard Road, Cottonwood, Arizona.

### ITEM NO. 1 Introductions [Co-Chair Jane Moore]

Co-Chair Moore called the meeting to order at 2:00 p.m. and welcomed those attending. Self introductions followed.

### ITEM NO. 2 Approve January 26, 2006 meeting minutes. [Committee]

Consensus reached to approve the January 26, 2006 minutes as written.

### **ITEM NO. 3 Informational reports** [Co-Chairs and Committee]

- Mary Hoadley reported that the U.S. Army Corp. of Engineers had supported a grant for studies in the Upper Agua Fria, however, Congress changed the rules so the court couldn't reprogram the money; so the momentum that was gained has been halted. Mary said they are in the process of writing a letter Renzi to see if something can be done to get things moving again. Hoadley also reported that they had a very successful cleanup in January in Mayer along Big Bug Creek and that another one is planned for Saturday, February 25<sup>th</sup> from 9 a.m. to 3 p.m. in Mayer along Big Bug and at sites along Antelope Creek Road.
- Co-Chair Moore announced that handouts from the Verde River Basin Partnership Forum are available if anyone is interested.

### ITEM NO. 4 Coordinator and TAC Reports [Coordinator John Rasmussen]

- ltem No. 1 of Coordinator's Report: Coordinator Rasmussen announced that at the upcoming March 15<sup>th</sup> Verde Watershed Association (VWA) meeting representatives from the Upper San Pedro Partnership (USPP) will attend to discuss the Partnership. The Coordinator made a plea to all WAC and TAC members to attend this meeting in order to gain a better understanding of how the USPP is organized and how it works. The meeting will be held at the Bradshaw High School in Prescott Valley starting at 10 a.m. Then on March 18<sup>th</sup> a meeting is scheduled from 10 a.m. to 2 p.m. at the Prescott College Crossroads Center to begin initial organization of the Verde River Basin Partnership (VRBP).

Anita Goss strongly suggested contacting state representatives supporting water bills she said the legislators have heard from the Prescott side but not much from the Verde side.
- ➤ Item No. 4 of TAC Report: The USGS Report, second presentation regarding water budgets further discussed in Item No. 5 of agenda.
- ➤ Item No. 5 of TAC Report: Spikedace Minnow Critical Habitat, USFWS proposed rule to redesignate 633 miles of streams in Arizona and New Mexico as critical habitat for Spikedace and Loach Minnow. The Coordinator said that the consultant assured him that there will be an opportunity to comment on the draft economic analysis when it is published prior to finalizing.

# ITEM NO. 5 Presentation – USGS Report: "Hydrogeology of the Upper and Middle Verde River Watersheds, Central Arizona" – Second presentation – Water Budgets. [Kyl Blasch, USGS and Leslie Graser. ADWR]

- Co-Chair Moore introduced the agenda item and turned over to Coordinator Rasmussen. Rasmussen explained that today's presentation is the second of three presentations. Today's presentation addresses Water Budgets and the third presentation will discuss next steps. He introduced Kyl Blasch and Leslie Graser.
- Mr. Blasch commented that the Report proofs were still at the printer, but should be ready real soon. He said that as soon as they receive it they will deliver.
- Ms. Graser gave an outline of the presentation which included: Definitions; Terms of water balance equation; Basin water budgets; Aquifer water budgets and Trends. Graser outlined boundaries used during the studies saying that it is important to remember how the water moves. ## ITEM NO. 6 Updates and possible action: HB 2277: System Water Plans (workshop planning) [Coordinator and Committee]

➤ **Consensus** reached for the Coordinator to finalize the tentatively scheduled workshop on March 20, 2006 in Cottonwood regarding HB 2277, System Water Plans for small water providers outside of an AMA.

# ITEM NO. 7 Updates and possible action: Discuss Laurie Wirt presentation (and schedule) of USGS Report "Geologic Framework of Aquifer Units and Ground-Water Flowpaths, Verde River Headwaters, North-Central Arizona (OFR 2004-1411)" [Coordinator/Committee]

- Coordinator Rasmussen told the WAC that he talked with Laurie Wirt and she indicated that she could be available to give a presentation to the WAC at their May meeting regarding her recently released USGS Report as titled above. She is requesting financial support for her travel from Denver to Yavapai County.
- No consensus reached completing discussion by the WAC to finance Laurie's trip to Yavapai County. If she can come on her own sometime in the future the WAC would be interested in hearing her presentation. Coordinator Rasmussen will contact Laurie and let her know that the WAC will not finance her trip to Yavapai County, but if in the future she is in Yavapai County doing some field work or for other reasons, the WAC would be interested in scheduling a presentation of her Report.

### ITEM NO. 8 Updates and discussion: 1) Verde River Basin Partnership (Forum results and future planning) and 2) Dewey-Humboldt Well Monitoring Form

- Coordinator Rasmussen again reminded everyone about the March 15<sup>th</sup> VWA meeting that representatives of the USPP will be attending to talk about the organization of the USPP; how the organization works; challenges that they worked through and the overall process.
- Co-Chair Roecker presented a handout of an outline showing how the VRBPartnership might be structured. This handout was the result of a meeting held in Prescott as a follow up to the February 11<sup>th</sup> Forum. The handout consisted of an organizational concept that would include an Executive, Technical and Other Committees as established by the Executive Committee. The Executive

Committee would provide direction of the Partnership, meeting objectives defined in Title II, final disposition of action items and funding directives. Members would consist of elected officials of governmental jurisdictions in the Verde River Basin. The Technical Committee would assist the Executive Committee with technical issues and members would be appointed by members of the Executive Committee. Other committees would be established as needed by the Executive Committee and members could consist of organizations, agencies, and interested individuals with specific expertise. There was some general conversation about the handout and what stakeholders should be considered as part of the VRBP. Discussion about the size of the group continued and how this Partnership can be formed to include all stakeholders that need to be included. A question to ask and discuss is: What is the purpose of the stakeholder group according to Title II?

- Coordinator Rasmussen wants to know who is going to work on planning the March 18<sup>th</sup> meeting? He said that he, Carol Johnson, Leslie Meyer, and Greg Kornrumph volunteered but more help is needed. Tom Hintez said he would also like to participate in the planning of the March 18<sup>th</sup> meeting. The Coordinator thought that the March 18<sup>th</sup> meeting was to discuss the organization of the Partnership and what stakeholders should be included in the Partnership.
- The Dewey-Humboldt Well Monitoring Form Item was not discussed and will be held until the March meeting due to time running out.
