Agenda Item 4: Coordinators Report and TAC Report

Budget: From "03/06 Financial Report": Account balance: \$322,025.15; YTD Deductions: \$52,707.99; YTD Additions: \$229,243.44 (Fiscal Year Starts July 1).

TAC Meeting:

- 1. **Arizona NEMO Program (ADEQ, Arizona Cooperative Extension, U of A):** Kristine Uhlman gave brief summary of the program and available resources such as GIS maps and hydro-modeling. Website: http://www.srnr.arizona.edu/nemo/index.php
- USGS Regional Modeling Meeting (Northern Arizona Regional Ground-Water Flow Model): Bill Meyer gave summary of March 31, 2006 meeting of peer review panel.
 Discussed objectives and planning, including data, model structure (boundaries, layering, etc), Inflows (Precipitation, recharge, etc), Outflows (ET, Pumping, Groundwater, etc).
- 3. **USGS Verde Reports:** TAC discussed White Paper for WAC regarding Blasch *et al* report. Two weeks after receiving the report, TAC members will have white paper comments to Coordinator for inclusion into White Paper. Anticipate White Paper will be together in one month.

TAC agreed that the three recent reports provide a great deal of information. There is enough information to do some things in the realm of regional water management strategies. While the model will be valuable, the WAC need not wait until the model is complete to address strategies and implications of strategies for the watershed.

Need to complete task of combining reports from communities into a report for the Board from the WAC. TAC anticipates this will lead to discussion and action on a regional plan.

- 4. Title II: TAC tasks from previous WAC meeting. "What have we done, and what don't we have, and need to fulfill technical requirements of Title II". TAC is focusing on two things at first: (1) section 204 b, water budget analysis (needs and existing information); and (2) section 204 a 2B, ongoing and completed studies (bibliography). (1) is being lead by work group consisting of Bill Meyer, Bob Hardy, Loyd Barnett and Ed Wolfe. (2) is being led by John Rasmussen, Leslie Graser and Dan Campbell. All products will be vetted by other TAC members and interested parties.
- **5. Presentation by Laurie Wirt (USGS):** Scheduled for next WAC meeting in Chino Valley (May 17th normal meeting date). (Verde River Headwaters report (OFR 2004-1411)). TAC will review her presentation with her prior to meeting in order to hear her reasoning and make presentation to WAC more effective regarding "burning issues".
